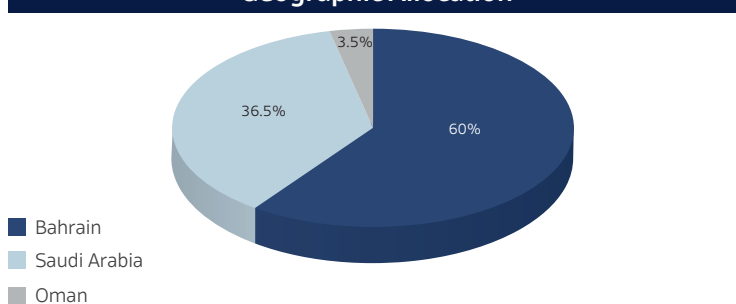

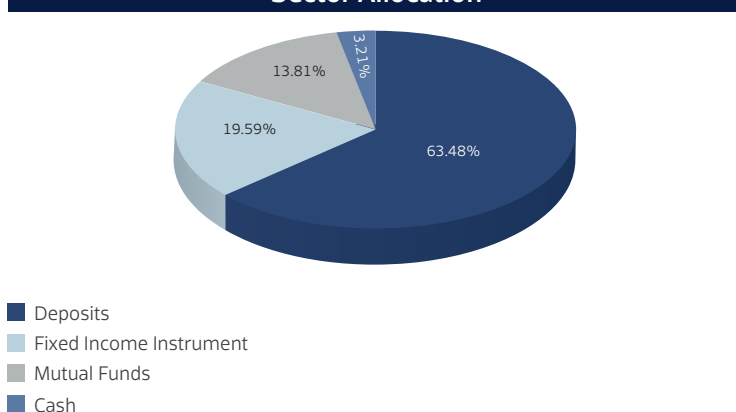

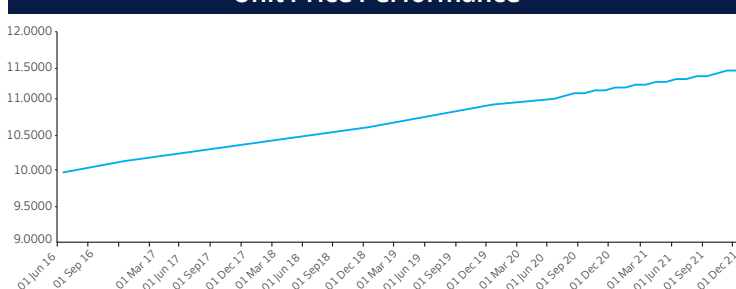
Geographic Allocation



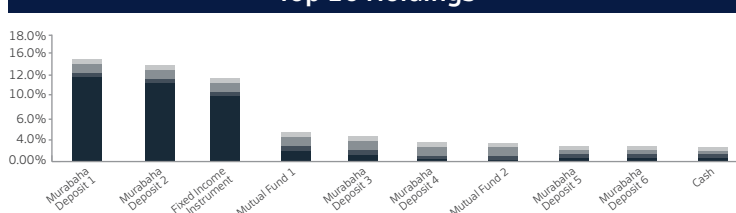
Sector Allocation
