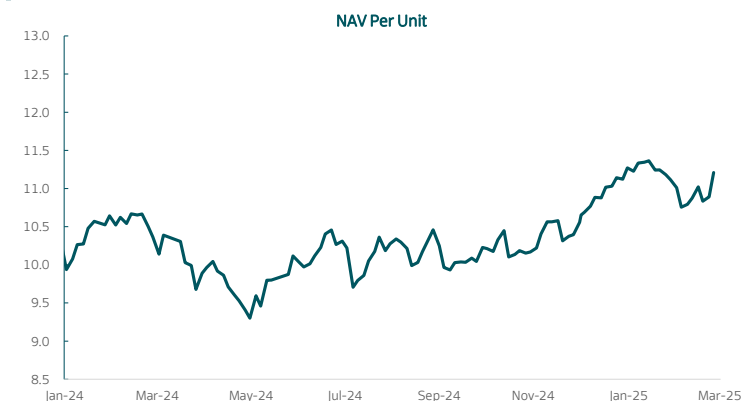

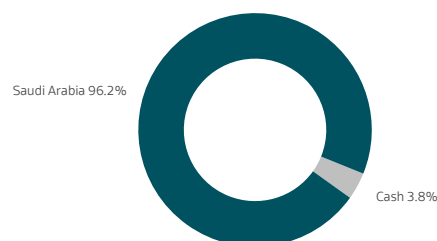

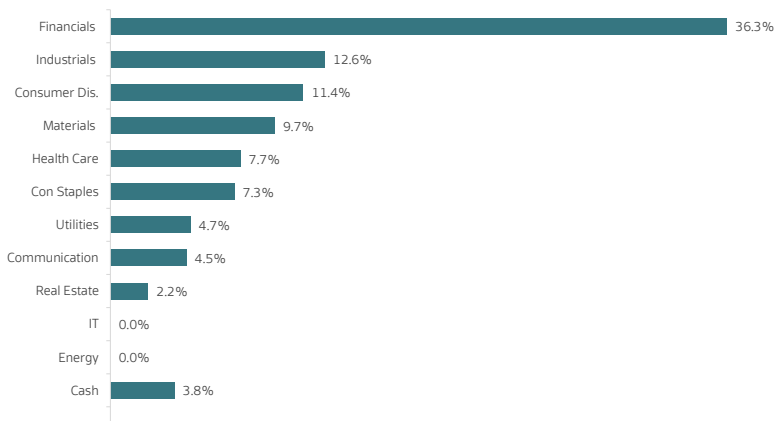

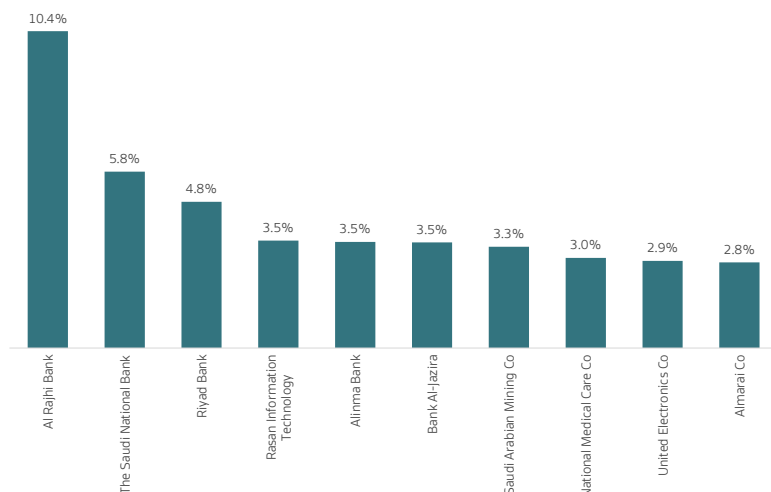
### Geographical Allocation
